Judge extends au pair ruling

Injunction on profits continues

WALTHAM — A federal judge yesterday made permanent an injunction that prevents killer nanny Louise Woodward from spending any money she makes from sale of her story until a lawsuit filed by Matthew Eappen's parents is settled this fall.

U.S. District Court Judge William Young's ruling prohibits Woodward, any of her family members and her representatives, from spending any money from selling her story and requires her to notify Sunil and Deborah Eappen if she makes a book or movie deal.

In the written ruling, Young noted the "tragic irony" that links Woodward to the Eappens.

"It is the tragic irony of this civil case that, whatever their

protestations, these parties need each other in the most practical sense: absent insurance, if (the Eappens are) to have any chance to collect upon his expected judgment, Woodward must amass the necessary funds, and the only potential source appears to be the same media that all parties agree are morally repugnant," Young wrote.

The Eappens filed a civil suit against Woodward on June 16, the same day the state Supreme Judicial Court upheld Judge Hiller Zobel's ruling reducing Woodward's second-degree murder conviction to manslaughter and set her free with a sentence of time already served.

In his ruling, Young made clear the injunction will last only until the civil trial, scheduled Oct. 5, is settled.

Moody Street's revitalization... Cronin's Landing, the Embassy Theatre," said Nocera. "Downtown Moody Street was one of the greatest downtown shopping areas outside of Boston."

The 2.3-mile, two-and-a-half-hour parade will begin at the corner of Gore and Grove streets, run west along Main Street, down Moody Street, and end at the corner of Maple and Crescent streets.

Not just Watch City residents are expected to turn out for the event, according to Karen Le-Blanc, executive director of the Charles River Museum and chairwoman of the float committee. The city has hired a publicist to spread word of the parade far and wide.

"So many things have happened to the downtown," said LeBlanc, "We really want a wide geographic area of people to come see the beautiful things done to the city."

Floats are best able to show the theme of Waltham's odyssey through time from industrial Middlesex County Volunteers, a colonial unit, in full uniform, according to Bill Walsh, parade chairman.

About 25 bands have already signed on for the parade, said Walsh, including area high schools, the Aleppo Shriners of Wilmington, UMass-Lowell Marching Band and, in an organizing coup, the coveted Boston College Marching Band.

"They were very hard to get, believe me." said Walsh.

The city's youth will be both represented and entertained. Children from all Waltham schools will participate in marching bands and floats, according to LeBlanc. And Walsh said the committee is "working on things for the kids right now," including a puppet show.

Peppered throughout the chronologically ordered parade will be 30 to 50 antique cars, which will be shown at the Gore Estate on the morning of the parade from 9 a.m. to 12 p.m., said Walsh.

noted that "there is an overwhelming likelihood that Eappen will succeed in establishing Woodward's civil liability for the death of Matthew Eappen."

The Eappens' suit seeks \$75,000 for medical and burial costs for the 8-month-old baby, as well as unspecified "punitive damages."

Their attorneys, Frederic Ellis and co-counsel Edward Bassett, asked Young for the preliminary injunction in an effort to prohibit Woodward from spending money she makes from sale of her story, although she has returned to her native England.

On June 17, Young granted the 12-day emergency restraining order that upheld the prohibitions while he considered attorneys' arguments. That ruling was set to expire today.

Norman Zalkind and Anthony Doniger, who represented Woodward during the June 17 hearing and argued the injunction infringes on her First Amendment rights, no longer represent the former au pair.

Woodward has publicly denied selling rights to the story.

"In light of (British newspaper) the Daily Mail's acknowledgment that it paid the Woodwards a down payment of \$66,000 for access to Louise Woodward and her family in November 1997 and other information, the Eappens believe that the Woodwards will attempt to further profit from this tragedy," Ellis said.

When Young issued the emergency restraining order, several legal experts questioned whether it would apply in England.

While there are laws that deal with extradition of those involved in criminal cases, there are no laws regarding civil cases, the experts said.
